- 1. For all the Syllabi, the course description entered in UWCM (Kuali) doesn't match the Syllabus course description. Please use other wording for the detailed explanation while using the same course description.

- 3. Curricular relationships should be reexamined for courses since indicating that courses are overlapping means that a student cannot take that course and the T BANLT course for credit, only one of the two.
