III. Policy Issues & Other Business

W, S, & R Designations update

Associate Vice Chancellor for Student Success, Bonnie Becker, provided an update on the status of W, S, & R Designations within units. Units are not meeting their designation deadlines for various reasons.

Actions:

• Deadlines for units to complete W, S, & R designations will be extended to June 1, 2019 (to the extent that this is possible).

• 'W' designation guidelines for each unit will be posted on the policies section of the APCC website.

W Course Caps or Lack Thereof

Discussion took place regarding the recommended enrollment cap for W courses, which is currently 25 students. Tammy Jez looked at enrollment statistics for W courses from Winter 2019 and found most courses were meeting these enrollment caps.

Further discussion took place regarding W designations at the unit level, including units removing W designations from their courses, how enrollment caps affect course availability, and workload of W courses on faculty.

Committee members discussed how support for W courses can be provided in the future, including through the Writing Advisory Committee and possible revival of the Campus Writing Fellows. This will be re-visited in the future.

PNOI Review Process

In response to APCC members being tasked with the PNOI review process in the next academic plan cycle, committee members reviewed the PNOI Review Process draft and the Academic Planning Rubric draft.

In addition to the PNOI Review Process and Academic Planning Rubric, Academic Affairs will have standardized measures for benchmarking available via the Integrated Postsecondary Education Data System (IPEDS) for the next PNOI cycle.

Actions:

- Committee members will make additional comments and edits on the Academic Planning Rubric and the PNOI Review Process document.
- APCC Chair, Menaka Abraham, will link the Academic Planning Rubric to the PNOI Review Process document.
- Executive Vice Chancellor for Academic Affairs, Jill Purdy, and Collections & Budget Librarian, Serin Anderson, will update UW Tacoma's organizational degree charts to also help with the next PNOI cycle.
