<p>OBJECTIVE 6: Revise and conduct follow up to the LCV survey at UWT.</p> <p>MISCELLANEOUS ACTIVITIES AND ACCOMPLISHMENTS</p> <p>1) Faculty Assembly co-sponsored a Shared Governance Retreat September 10th, 2006.</p> <p>2) Faculty Assembly (with the help of computer services) redesigned the FA webpage.</p> <p>3) Faculty Assembly submitted the 2007-2009 budget.</p> <p>4) At the request of the Interim Vice Chancellor, Faculty Assembly supported the work of an Ad Hoc Committee on Schools and Colleges.</p> <p>5) Faculty Assembly participated in the search for the Vice Chancellor of Academic Affairs.</p>	<p>After consulting with the Staff Association and Chancellor and Vice Chancellor, Marcy met with the Executive Vice Provost, Ana Mari Cauce to discuss a follow-up to the Leadership, Community, and Values survey given in 2005.
